

2017 Prescription Safety Campaign

Educating doctors and patients on safe prescription management strategies and the dangers of opioid misuse

Bone and joint conditions, injuries and surgeries are often painful. Orthopaedic surgeons are committed to helping their patients live as comfortably and pain-free as possible. Opioids are prescription pain relievers. When used as recommended, opioids can alleviate severe pain, especially during the hours and days immediately following an injury or major surgery.

However, opioids are not a solution for persistent pain.

Today, the U.S. is in the midst of an opioid epidemic, with millions of people dependent on or misusing prescription painkillers such as codeine, morphine, oxymorphone, tramadol, hydrocodone, or oxycodone.

Orthopaedic surgeons are committed to the safest pain relief strategies. The Academy recently launched a multi-faceted campaign to educate orthopaedic surgeons and their patients about the dangers associated with opioids.




A 2016 Washington Post/Kaiser Family Foundation survey found that 1 in 3 patients who recently took opioids for at least two months reported trouble stopping them.

Campaign Highlights

1. Prescription Safety PSA Campaign

To highlight the potential dangers of opioids, the AAOS launched a public service announcement (PSA) campaign this month that includes print and radio ads urging doctors and patients to exercise caution in prescribing and taking opioids. The PSAs were distributed to more than 5,000 media, including television and radio stations, print publications and outdoor billboard/sign companies.


The radio spots, created in partnership with the Orthopaedic Trauma Association, emphasize the importance of moderation in prescribing opioids. The ads feature an orthopaedic surgeon telling a patient who is in pain: "We're being very careful with prescription painkillers. Let's continue with therapy and off-the-shelf anti-inflammatories now." The ads conclude with the message: "Prescription painkillers are America's newest epidemic causing abuse and addiction for millions. The smaller the dose prescribed and taken, the better."

4. Revised Information Statement

Recently, the Academy approved the information statement, "Opioid Use, Misuse, and Abuse in Orthopaedic Practice," calling for a comprehensive program to decrease opioid use, misuse and abuse in the U.S. Among the strategies outlined in the statement:



- Standardized opioid prescription strategies.
- Avoidance of extended-release opioids, preoperative opioids for non-traumatic problems, and prescription of opioids for patients that don't have an acute injury or surgery.
- The implementation of compassionate, effective communication strategies between doctor and patient regarding pain relief.
- Professional, interpersonal, and organizational collaborations to discourage opioid misuse.
- Improved care coordination and opioid use tracking.
- Continuing Medical Education (CME) for physicians on safe and effective pain relief.

5. AMA Partnership

In addition to approving the new information statement, the Academy is among 27 physician organization members of the American Medical Association's (AMA) Task Force to Reduce Opioid Abuse, committed to identifying the best practices to address the opioid public health crisis and moving swiftly to implement new practices across the country.
